E-tenders (**both Technical and Commercial**) are invited from bonafide, experienced, and financially sound firms / Company specialised for installation of Mobile Tower on available ground space at the Baruipur Bus Terminus under this Company.

The offers should include the following:

1. Lay-out Drawings showing the exact location of the Tower within each premises.
2. The specification of such Tower with detailed measurement. The bidder must ensure that such installation will not disturb the structural stability of the building.
3. Provisions for power input, as required.
4. Provision for access for upkeep and maintenance of the equipment.
5. Prior permission from the appropriate Authority on permissible radio activity norms, establishment of telegraph infrastructure norms and other issues as per West Bengal Telecom Infrastructure Guidelines, 2020 (Memo No. 585-Estt/ITE-20012/2/2020 dt. 28.12.2020).
6. Copies of PAN, GST, Professional Taxpayment certificate, Trade License of the bidder.
7. Appropriate Credential of similar work done in the premises of any Govt. Sect. / PSU / renowned private land / Building.
8. Universal Service Access License from DoT, GOI, copy of SACFA, Declaration of radiation issued by TERM, structural stability certificate from authorised agency, copy of SST/SBC.
9. The bidder should have no dues to any government authority / organisations on any business of similar activity.

### **PAYMENT OF LICENSE FEES:**

The Company intends to enter into a Leave and Licence Agreement for 5 years for erection of mobile towers on its ground, with the successful bidder with *full payment of agreed value in advance or 1 year's rent in advance within 15 days of execution of contract, with appropriate financial bank guarantee for 4 years, including applicable taxes.* The BG should be drawn on any Nationalised Bank at Kolkata with validity of extra 6 months. Any offer below market rate / base rate Rs. 40,000/- will not be accepted. The successful bidder will have to pay one time sanction fees of Rs. 2 lakh plus GST per tower for approval of contract. The successful bidder will also have to pay initial payment of Rs. 1.5 lakh plus GST per tower other than license fees, before issuing office order. The rate should be quoted for one Telecom Service Provider and Rs. 30,000/- will be added for each additional Telecom Service Provider, maximum 4 providers. The installer company will provide an undertaking that how many service providers they will accept, before entering into agreement.

### **DOCUMENTS TO SUBMIT WITH TECHNICAL BID:**

Copies of last 5 yrs I.T. Return, GST Return in GSTR9 (if any), Professional Tax Payment Certificate, Company registration with ROC documents, Trade License, PAN and GST registration certificate, Partnership Deed (if any) and other statutory requirements as mentioned above have to be submitted by the Bidder in technical bid.

Bidders with negative net worth or loss during the 5 previous years starting from 2016-17 will not be considered.

**CREDENTIALS** : Tenderers holding long term lease in similar nature as exist at least for last 5 years, should mention the same with necessary relevant documents in technical bid. These will be treated as Credential of the tenderer.
