JOB SCHEDULE FOR BUS BODY REPAIRING & PAINTING

BODY:-

Full bus body (outside & inside) patch repairing to be attended.

PASSENGER SEATS:-

Seat with backrest are to be repaired with new rexine, 12 mm thick plywood & HD foam for standard buses / suitable cushion with fabrics for plastic moulded seats as per requirement.

PAINTINGS:-

All painting surface are to be thoroughly degreased with suitable organic solvent, followed by mechanical roughening so as to produce a surface on which the primer & paints can adhere to. The surface should then be spray-painted & finished as per WBTC specification with air drying synthetic enamel of high grade & approved quality. The exterior & interior paintings shall be in four coats including one coat primer, one coat filler, & two coats of finished paints.
