Offers are invited from bonafide, experienced and financially sound vendors for the following:

**Auction of 20 (Twenty) nos. of trees within Tollygunge Tram Depot 257, Deshpran Sashmal Road, Kolkata – 700 033 which are to be disposed by felling & removal for installation of CNG Station.**

- i) **The Bidders have to download the document from website and after filling up the same they have to submit it along with EMD and other relivant documents in sealed envelop within the drop box at 2<sup>nd</sup> floor of Paribahan Bhawan at 12, R. N. Mukherjee Road, Kolkata – 700 001 within 12.30 pm on 28.03.2025. The bidders may also offer their bid online through [www.wbtenders.gov.in](http://www.wbtenders.gov.in).**
- ii) Details of trees are mentioned in the schedule. The trees to be disposed are numbered for identification.
- iii) **Locations of trees** : adjacent to boundary wall facing N.S. Road and North Dormitory Mess Building of Tollygunge Tram / Bus Depot 257, Deshpran Sashmal Road, Kolkata – 700 033.
- iv) **The last date of submission of Bid in prescribed format : 28.03.2025 at 12:30 PM.**
- v) **The opening date of the Bid : 02.04.2025 at 2:00 PM**

**Terms & Conditions of Auction :**

- i) The interested bidder may visit the trees at Tollygunge Tram/Bus Depot with prior intimation before participation in the auction.
- ii) All the bidders have to submit an **Earnest Money Deposit of Rs. 19,000/- in Demand Draft / Pay Order** drawn in favour of ‘**West Bengal Transport Corporation Limited**’. No offer without EMD would be accepted. The said EMD amount would be converted as Security Deposit (SD) which will be refunded

without interest only after satisfactory completion of work and due certification by the Engineer-in-charge.

- iii) The bidders must have to fill up their offers for all the trees in prescribed format given in the website and will quote the rates and GST separately which will be payable to WBTC.
- iv) Accordingly, the bidders have to submit the following documents **in sealed envelop along with the Earnest money** (in DD / Pay Order) and will drop the same in the Tender Box kept at 2<sup>nd</sup> floor of Paribahan Bhawan at 12, R. N. Mukherjee Road, Kolkata – 700 001 positively within 12:30 PM on 28.03.2025. The envelop should be addressed to the Managing Director, WBTC and the bidders name, full address and contact number must be written at the bottom left hand corner of the envelop.
  - 1. Prescribed format duly filled up **for all the 20 nos of trees.**
  - 2. Earnest Money Deposit of **Rs. 19,000/-** only in DD / Pay Order.
  - 3. Copy of self attested Pan Card.
  - 4. Copy of self attested Aadhar Card.
  - 5. Copy of Trade Licence as applicable.
  - 6. Full name of the Company / Firm / individual with full mailing address, contact no, mail ID no.
  - 7. One cancelled cheque leaf.
- v) The successful bidder shall have to pay the full amount of the bid positively within 3 (three) working days from the date of issue of letter instructing for making the payment, failing which his offer would be treated as 'Cancelled' and Earnest Money will be forfeited.
- vi) The work order for felling & removal of trees would be issued only after making the full payment within stipulated period.
- vii) The successful bidder must have to **remove all 20 nos. of trees along with the entire routes** after necessary excavation of earth in all respect as per direction of Engineer In-charge. The entire job, including site clearance, is to be completed positively within 15 days from the date of handing over the site. Otherwise, his claim over the said trees will not be entertained by WBTC.

- viii) All necessary arrangements for disposal of trees are to be made by the successful bidder strictly as per rule of WBTCL and the entry & exit of their manpower, vehicles, tools & plants etc. are to be duly notified in advance to the concerned authority as it is a highly protected place. Once work order is issued, WBTCL will have no responsibility for any assets of the vendor kept within the premises during the period of such disposal. They have to undertake the work at their cost, risk & responsibility.
- ix) Force Majeure Clause: If for any reason related to change in Government policy or any such other factors, the job in question is to be kept suspended by WBTCL, the successful bidder would be bound to accept the same. No additional claim would be accepted by WBTCL in this respect.
